  - c. Attach the original or copy of the proof of purchase (invoice[s]/receipts[s]) for the eligible product(s). Please circle the purchase price(s) on the invoice.

### SECTION IV: HP AUTHORIZED RESELLERS' CLAIMING PROCESS ON BEHALF OF CUSTOMERS

1. How to participate:
  - a. HP Authorized Resellers may only claim on behalf of their public sector customers where the reseller has given the rebate to the customer up front, at the point of purchase.
  - b. HP Authorized Reseller indicates whether the purchaser is a government or education customer.
2. How to submit a claim:
  - a. Same as customer claiming process.
